#### **Refer Your Patient**

To refer a patient for genetic counseling, please use this link: **refer.informeddna.com** and complete all necessary information, including insurance information and any relevant medical records.

InformedDNA will contact your patient to set up their initial telehealth genetic counseling appointment. Appointments are available days, evenings, and weekends.

To prepare and inform your patient, tell them you are referring them for genetic counseling with InformedDNA, to expect a phone call and email, and provide them with the 'Your Provider Referred you for Genetic Counseling' handout.

# **Scheduling**



#### Patients will be contacted

within two business days of receipt of the referral and offered a telehealth consultation within 5-10 business days.



For urgent treatment decisions, patients will be contacted the same day a referral is received and offered an appointment within 1-4 business days.

## What To Expect from the Genetic Counseling Appointment

- At the scheduled time, your patients will log in to their secure telehealth visit with their assigned genetic counselor.
- Appointments on average take about 40-60 minutes.
- The genetic counselor assesses the personal and family history, determines what genetic conditions the patient may be at risk for, discusses testing.

### **Cost/Billing**

- **Genetic Counseling costs:** InformedDNA will bill the patient's in-network health plan and collect any copay and coinsurance. We are in network with many nationwide health insurances, as well as many regional insurances.
- InformedDNA does not bill out of network insurances, and instead patients are billed a self pay rate per appointment: \$249 for the initial consultation and \$99 for the follow up appointment.
- **Genetic Testing costs:** Billed separately by the reference lab directly to the patients' insurance. The genetic counselor will discuss this process with the patients during the appointment.

# **The Genetic Testing Process**

- 1 If genetic testing is being pursued, a pre-test consult note and pedigree will be sent to you. This note outlines the clinical recommendation and specific test being pursued by the patient.
  - Typically no action items are needed by the provider.
  - InformedDNA's genetic counselors submit prior authorizations for our in-network insurance companies, and the consult note serves as a letter of medical necessity for the reference lab.

# 2 Test Facilitation Steps

- If genetic testing is elected, InformedDNA's team will submit the test order to the reference lab with the referring provider as the ordering healthcare provider\*.
- A saliva collection kit will be sent directly to the patient's home by the lab; the patient will collect the sample and return it to the lab in a pre-paid envelope/box.
- Test results are sent directly from the lab to both the referring provider and InformedDNA within two to three weeks of receiving the sample.
- 3 InformedDNA provides results disclosure via a post-test telehealth genetic counseling appointment, results interpretation, support and management discussion with the patient.
- 4 If no testing is pursued, or a post-test genetic counseling appointment has occurred, a summary report and pedigree will be sent to the referring provider via fax, and to the patient through InformedDNA's secure portal.
  - This note outlines the clinical assessment, test results (if pursued), interpretation, risks and management recommendations based on best practice guidelines.
  - · All cancer specialty appointments will include for unaffected women a breast cancer risk assessment.
